## **Instructions for NEET PG- 2023 Uttarakhand State Centralized Counselling (FAPUS- Courses)**

**(In compliance to Uttarakhand GO 986/XXVIII-2/2014/01 (45)2014 dated 23 June, 2015)**

1. हिमालयन इन्स्टीट्यूट ऑफ मेडिकल साइन्सेज में संचालित फ़ैपस पाठ्यक्रम में प्रवेश हेतु काउन्सिलिंग नीट पी0जी0-2023 की मेरिट के आधार पर की जानी है।
2. काउन्सिलिंग हेतु पंजीकरण शुल्क रुपया-6500/- देय होगा जो कि डिमाण्ड ड्राफ्ट के माध्यम से वित्त नियंत्रक, हे0न0ब0उ0 चिकित्सा विश्वविद्यालय के नाम में देय होगा।
3. फ़ैपस पाठ्यक्रम में प्रवेश हेतु काउंसिलिंग विश्वविद्यालय मुख्यालय न्यू सेन्ट्रल होप टाऊन, बायांखाला, सेलाकुई, देहरादून, उत्तराखण्ड में पंजीकृत अभ्यर्थियों की उपस्थिति में भौतिक रूप से आयोजित की जायेगी।
4. काउन्सिलिंग हेतु रिपोर्टिंग का समय 06.07.2024 प्रातः 10:00 बजे से मध्यान्ह 12:00 बजे तक रहेगा।
5. फ़ैपस काउन्सिलिंग हेतु दिये गये उपरोक्त तिथि एवं समय के अनुसार अर्ह एवं भौतिक रूप से उपस्थित समस्त अभ्यर्थियों की सूची दिनांक 06.07.2024 को अपरान्ह 12:30 बजे चस्पा की जायेगी। उसके उपरान्त किसी भी अभ्यर्थी को काउन्सिलिंग बोर्ड द्वारा सीट आवंटन की कार्यवाही में सम्मिलित नहीं किया जायेगा। सीट आवंटन का कार्य दिनांक 06.07.2024 अपरान्ह 01:00 बजे से किया जायेगा।

### **Eligibility:**

- a. All interested eligible candidates will have to register afresh by offline mode only as per schedule to become eligible for FAPUS counseling.
- b. Candidates who will not present (offline) will not be eligible and/or considered for FAPUS counseling.
- c. All the candidates who have qualified the NEET (P.G.) 2023 examination are eligible to participate in FAPUS counseling
- d. **Qualifications for Fundamentals of Abdomino-Pelvic Ultrasonography (FAPUS)—  
Level one for MBBS Doctors- 06 months course.**
  - Is an Indian citizen.
  - Has passed the M.B.B.S Examination from a Medical College, recognized by the MCI.
  - Must have fulfilled all eligibility criteria mentioned in the NEET PG-2023 brochure and qualified NEET PG-2023 examination.
  - Has completed compulsory rotatory internship training on or before 08.11.2023. No request for time relaxation in compulsory rotatory internship under any circumstances will be accepted.
  - Registration with M.C.I./State Medical Councils is compulsory and its documentary proof should be uploaded at the time of online counselling and submitted at the time of admission in allotted college. Candidate has to register himself/Herself to Uttarakhand State Medical council within 02 months of joining the PG course.

The FAPUS level I course of 06 months duration will be conducted in two batches in the following institutes:-

### Procedure:

- a. FAPUS Counselling will be conducted by Off Line mode only.
- b. All the candidates have to register for FAPUS counseling by payment of registration fees of Rs. 6500/-
- c. The Registration fee is to be paid by DD in favor of Finance Controllor HNBUMU payable at Dehradun

### 2. Document Details:

Candidates are required to produce following self attested documents/certificates at the time of registration during offline counseling:-

Note: \*Candidates who are undergoing internship & likely to complete on or before 11.08.2024 have to furnish a certificate from the Principal/Dean of the Institute stating the facts but originals are to be submitted at the time of confirming the admission.

- High School (10<sup>th</sup>) pass certificate.
- \*MBBS Degree Provisional/Permanent.
- \*Internship Completion certificate.
- \*Registration Certificate with State Medical council/Medical council of India
- NEET PG -2023 Score card
- Identity proof as Aadhar card (Preferably), Voter card, Passport, Driving Licence, etc.
- Domicile/Permanent Residence Certificate issued by the competent authority of Uttarakhand only, if applicable.
- Certificate of Reserve category, if applicable.
- Certificate of Sub Category, if applicable.
- NOC from DG Health & Family Welfare Uttarakhand/Competent Authority for regular PMHS Uttarakhand candidate/candidates serving under the service bond.
- NOC from competent authority for all in-service regular candidates other than PMHS of Uttarakhand candidates.
- OBC Candidates are advised to check his/her OBC certificate carefully and ensure that it is valid, because the OBC certificate is valid for three years duration only from date of issue.

### **3. Choice Filling:**

Candidates must fill choices for FAPUS counseling for seat allotment as per Seat Matrix available on the website.

### **4. Allotment:**

Allotment of available seats will be done by the Counseling Board purely on the basis of NEET PG-2023 State merit list of FAPUS counseling of the eligible candidates and choices filled by the candidates.

### **5. Admission:**

The candidates have to secure the admission in the allotted college at counseling venue.

### **6. Conversion of Seats:**

If any State quota seats remain vacant due to non availability of interested eligible registered candidates of their respective categories, then these vacant seats will be converted as per existing rules.

### **7. General Conditions:**

- (a) The Counselling Board/University will not be responsible for any mistake committed on the part of candidates during counseling process.
- (b) Candidate must fill application form carefully, as once submitted application form cannot be changed/edited later under any circumstance
- (c) No request for extension of last date of admission will be entertained in view of guidelines of NMC / Hon'ble Supreme court.
- (d) All the rules and regulations are subject to change as per the directions of the Hon'ble Courts/ Govt. of India/NMC/Govt. of Uttarakhand guidelines.
- (e) Candidates are advised to visit the university website regularly for any updates.
